Product Warranty

All Glide Free Design foiling kits come with a 24 month warranty which warrants that the foils and associated parts will be free from defects in materials and workmanship for the Warranty Period under conditions of "reasonable use".

This warranty is limited to repairs and replacement of any part or parts of its manufacture which has been inspected and found to be at fault due to a defect in manufacture or workmanship within the applicable conditions of this warranty and the conditions of sale.

The Customer is responsible to refit any replacement parts, suitable instructions will be supplied.

The warranty policy may be transferred with the foiling kit upon the sale to a third party only with the consent of Glide Free Design.

Exclusions:

This warranty expressly excludes damage to the boat and fittings as this is outside our control.

Glide Free Design is not liable to the buyer for damage caused to the foiling kit and its associated parts by:--

- Wear and tear
- Accident
- Collision
- Running aground
- Inexperience
- Vandalism
- Neglect
- Improper set up and use
- Non approved repair
- Transportation damage
- Storage damage

Safety

Glide Free Design has taken considerable care to introduce several safety features into the product to reduce the risk for damage to the boat, loss or damage to components or injury to

the user. These items include a safety hook for the centreboard, a unique quick release function of the centreboard, the centreboard clears the boom when retracted and the boat can be launched in shallow water and the rudder is retractable.

While we have taken every opportunity to design in safety features, it is extremely important for the skipper to read and fully implement the operating manual provided by Glide Free Design. Due to the nature of operation of a sailing vessel, no further responsibility can be taken by Glide Free Design for the safety of the user.

Recall

Should a recall of components be implemented, replacement parts will be supplied by Glide Free Design. The Customer is responsible to refit any replacement parts, suitable instructions will be supplied.

Distributor Warranty

Glide Free Design will replace faulty parts as per this warranty. Assessment shall be based on evidence submitted by the distributor. The distributor will be responsible to fit the replacement parts supplied by Glide Free Design.

Service

From time to time, the customer may require service of the Glide free foils product. Service under this warranty should be provided by any authorised Glide Free Design approved distributor. Freight charges from the factory will be at the customers expense. Labour may be charged at the ruling rates applicable at the time of service.

Registration

This warranty is the only warranty applicable to the goods and is expressly in lieu of any warranties or conditions otherwise implied by law. Provided that nothing herein contained shall operate in any way to restrict, exclude or modify all or any of the provisions of Division 2 of the Australian Trade Practices Act 1973, the exercise of a right conferred by such a condition or warranty implied by any provision of Sections 18, 19, and 20 except Section 19 (4) of The Sale of Goods Act 1923 as amended. The original owner must return this warranty registration to Glide Free Design within 7 days of taking delivery of the goods.
